**Express Assumption of Risk, complete waiver agreement
not to sue and indemnity agreement.**

In return for the use today and on all future dates of the property, facilities and services (“the facilities”) of Jeepspeed and each of its subsidiaries and affiliated corporations the undersigned (Competitor) for him/herself, cp-driver’s, support team members, their heirs, assigns and legal representatives, hereby expressly agrees to:

1.) Assume any and all risks involved in or arising from activities

including, without limitation, the risk of death, bodily injury or property damage resulting from collision between a vehicle with another person, or a person or a stationary object, skidding, overturning, sudden stops, braking or acceleration, fire or explosion, the unavailability of emergency medical care, or the negligent or deliberate act of another person.

2.) Release

Jeepspeed, Don-A-Vee Motorsports, LLC., the event, and all of its successors, sponsors, assigns, subsidiaries, franchisee’s, affiliates, officers, directors, employees and agents from, and AGREES NOT TO SUE them on account of or in connection with any claims, causes or actions, injuries, damages, cost of expenses arising out of drivers use of, or presence at the event, including, without limitation, those based on death, bodily injury or property damage, whether or not caused by the negligence or other fault of Jeepspeed and it’s affiliates.

3.) Waive

The protection afforded by any statute or law in any jurisdiction (e.g. CA Civil Code 1542) whose purpose, substance and or/ effect is to provide that a general release shall extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.

4.) Indemnify and defend
